Do you have a plan for natural disasters?

Are visitors required to use an intercom before entering the building?		
Is there a designated visitor sign-in area?		
Are visitors required to sign in and given school issued identification badges?		
Is there a well defined reception area?

Are walkways or pedestrian paths well lit?		
Does your security system encompass detached buildings (sheds and field houses) and temporary buildings, as well as maintenance equipment in fenced off areas?
